1. The firm will be the only photographers allowed to photograph show wins. Local news photographers will be allowed upon mutual agreement. Photographers for a **CLUB** website will be allowed upon advanced notification and agreement with a disclaimer. We will work out the wording of the disclaimer, if needed, together.
2. After almost 40 years in the business of dog show photography, and 50 years of breeding, showing and doing performance events with our dogs; our company has been forced to see that people who participate in performance events rarely, if ever, want to have an official win photo taken. Performance judge's also appear to be quite happy to pose, in the ring normally, for cell phone photos with the exhibitor and the ribbons included. This is a breach of contract. If the photographer attempts to enforce this breach it rarely goes well and leaves a bad impression. It is always our goal that once you sign the contract you won't have any issues coming from our direction. We have made the difficult decision that we will cover performance events **ONLY** when requested by the club, and with the full backing of the club to meet our contract. Be aware that this also means that your club does not receive the images from us for your album, if they are not taken! IF you/your club wishes us to cover your performance event(s), we are happy to do so, just let us know you want us there, and are willing to back us on the contract.  
Should performance events and conformation be side by side the photographer will stay no longer than 30 minutes after the completion of the conformation side unless the performance chair or show chair has directly requested it. If you do wish to have us on hand for those photos please make clear that these "selfies" are a breach of contract and will not be tolerated and assist the photographer by enforcing that, and specifically, let our agent know you will be doing so!
3. PBL will supply the club with one (1) free 8x10 color high resolution image of the following, if taken: each regular group win, High in Trial, High Combined, all Best in Show and Reserve Best in Shows, Best and Reserve Best Junior Handler for each day. Images will be available for download from our website either when the show "expires" on our website (90 days after the show) or sooner if needed and we are notified. You can receive a physical album for \$50/day or both JPEGs and 8x10s for \$75/day. The host club agrees not to sell or give away images to anyone, including owners, breeders or handlers, they are for official club use only. The host club reserves the right to publish the official photos of the winners on their website and any other source it deems fit.

4. All shows deserve to have a qualified photographer on site for their win images. Due to high expenses and low income dog show photographers are often not able to cover small shows. Beginning in **2025** if your show has drawn fewer than 500 dogs at its most recent show on the same AKC corresponding date calendar weekend we need to charge a fee to assure only that we are not losing money for the weekend. This fee of \$200/day is payable by the end of the weekend. In lieu of the daily fee the club can supply a room in the judge's hotel, excluding incidentals, for the photographer. The dates the hotel room is reserved for should be from the night before you wish the photographer to work until the night they are done working. For example if you want the photographer to work Tuesday-Thursday, they will need a hotel Monday-Thursday nights.
5. Lead-in and concurrent specialties at the same location as the show will also receive an album of major wins that have been purchased. If a club has shared album images with owners/breeders/handlers they will no longer be eligible to receive an album.
6. We will supply free downloads for Best and Reserve Best Junior Handler photos for each day of the all breed and lead in & concurrent specialties for the winners of these awards.
7. A premium list, judging schedule. catalog & parking pass (where applicable) will be supplied by the club. The company only supplies necessary photography equipment and a qualified photographer; examination tables, ramps or podiums are not provided.
8. We are now doing "load as we go;" typically getting images online the same day they are taken or the next, depending on the size of the show. This can **ONLY** be done at locations that have wifi at this time. Please supply the wifi network name & password below for our use if possible.
9. One copy of this contract is to be signed by an authorized club official and returned to Photos by Lennah.
10. A copy of your club logo can be emailed to the address below or mailed with your copy of the contract and it will be included in my signage.
